Is Your Business Ready?

With a new government initiative regarding waste separation and collection on the horizon for England, businesses may wonder how this gradual shift will affect them. However, as Douglas Adams famously reminded us, 'Don't Panic.' It's not as bad as it sounds. In fact, things are only getting simpler.

Separating waste can be a complex and time-consuming process, especially when dealing with multiple waste streams. Fortunately, the new initiative will simplify this process.

What Will Be Collected?

The legislation will make the regular collection of six types of waste mandatory.

Types of waste:

- Paper and Cardboard
- Glass
- Food Waste
- Plastic (including plastic film from 2027)
- Metal
- General Waste

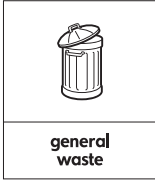
Households will continue to benefit from regular, free waste collections for all applicable waste types, as organised by councils and local authorities. However, businesses will be responsible for their own waste disposal, which may incur costs and require arrangements with private waste collectors.

Household waste collections will occur at stipulated dates and regular intervals, often depending on each local authority. Businesses, on the other hand, will not be bound by specific dates and timeframes allowing them to structure their waste collections more flexibly and to their waste management needs.

As per the Environment Act 2021 and Food Waste Regulations, businesses that produce more than 5 kg of food waste per week must separate food waste from general waste by the March 31st deadline.

Waste will be separated as follows:



Please Note: You'll only need a minimum of four bins (three if your waste collector chooses to combine paper and card with other dry recyclables), or one multi-stream bin that can collect all applicable waste streams.*

**While paper and card should be separated from other dry recyclables, your waste collector may still collect them together. We recommend first speaking to your waste collector to determine which option would be best for your business.*

Who Will Be Affected?

The new legislation will directly affect businesses, and non-domestic premises such as schools and hospitals.

Businesses and non-domestic premises with more than ten employees will be the first called upon to rejjg their recycling practices to align with the newly introduced government rules.

Micro-firms with ten or fewer employees are set to follow on March 31st, 2027, giving them more time to update and adjust their waste management to the upcoming changes.

Legislation Timeline

Once the government begins introducing the legislation, things will move quickly. To give you more of an overview, we have created a timeline for when collections for specific waste streams will be introduced. This way, you can remain prepared for any upcoming changes that may affect you.



Dry Mixed Recycling (Plastic, Metal and Glass)

- By 31st March 2025 - Businesses and relevant non-domestic premises
- By 31st March 2027 - micro-firms

Food Waste

- By 31st March 2025 - Businesses and relevant non-domestic premises
- By 31st March 2027 - micro-firms

Plastic Film

- By 31st March 2027 - Businesses, non domestic premises and micro-firms

Paper and Card

- By 31st March 2025 - Businesses and relevant non-domestic premises
- By 31st March 2027 - micro-firms

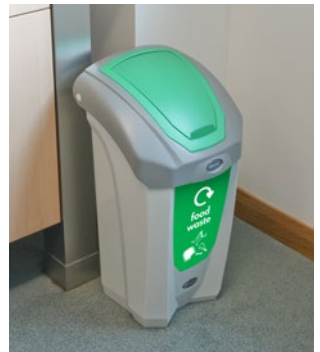

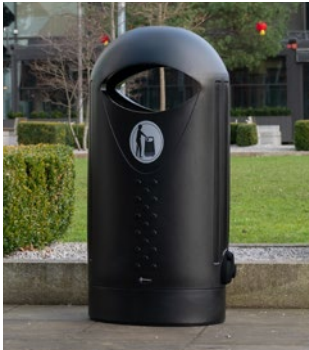
